### Welcome Back!

The district is pleased to report that today, 11/2/2020, all students, faculty and staff that were directly impacted by the positive COVID case of the Grade 1 student at Rouses Point Elementary have returned to school. The impacted parties have all successfully completed quarantine and the student and their family are doing well. Thank you to all of our affected families for your flexibility, patience, understanding, and support during this challenging time. We are very pleased that all of our Rouses Point Elementary classrooms are in full operation.

# **Dining Service Employee Tests Positive**

The district contracts with Chartwell's Dining Services to provide meals for our students and staff. We learned over the weekend that a Chartwell's employee was diagnosed with the coronavirus (COVID-19). Following contact tracing from the Clinton County Health Department, four additional employees have been ordered to quarantine because of their close contact with the COVID-positive employee. All spaces the employees occupied have been disinfected. The reduction in staff has resulted in the relocation of some Chartwell's employees to assist in other buildings, as well as in a reduced menu. ONLY sandwiches and pizza will be served until at least Tuesday, November 10, 2020. We send our best wishes for a safe and healthy return to the staff.

#### **NEW Requirement from the Health Department Regarding Masks**

Mr. John Kanoza, Director of the Clinton County Health Department, recently released an announcement that students and staff in ALL schools in Clinton County must wear face masks/coverings at all times. Governor Cuomo has granted authority for local health departments in New York State to impose this mandate on local districts. Per the mandate, mask breaks will no longer occur during instructional times in the classrooms. Adult-led and organized mask breaks will be provided in the classroom during mealtimes and for brief periods outdoors. Masks will still be worn during recess and physical education classes. We understand the challenges relating to this mandate and we will assist our young people with adhering to the requirement. We appreciate your patience and support as we adapt to the ever-changing requirements/mandates being implemented for the safety of our community.
