Workshop Topic

- 1. Projected Revenue Review for the 2015-2016 School Year by Lisa Grenville:
 - Increase Tuition Rate for Vermont Students
 - Increase Real Property Tax (Tax Levy) by 2%
 - \$208,320
 - Requires a Super-Majority Vote by Citizens
 - 60% or more of voters must approve the budget
- 2. Governor's Reform by Lisa Grenville
 - Education Reform "Education Opportunity Agenda"
- 3. Governor's Reform by Jennifer Brown, Business Manager:
 - Real Property Tax Relief Credit "Circuit Breaker" Rebate
 - STAR
- Eliminate \$41 million in annual STAR breaks to affluent taxpayers in NYC
- Move the STAR credit from a credit on school tax bills to a credit on personal income tax returns for new homeowners
- Hold flat total cost of providing STAR benefits to all homeowners
 (currently capped at a 2% annual increase

4. Next Budget Workshop, Lisa Grenville:

- A Budget will be Presented using the most Current Revenue Information (as of right now it will be a budget \$258,080 <u>less than</u> the 2014/15 budget and will include a proposed 2% Tax Increase)
- The Budget will include all changes to programs/staffing that are necessary to stay within "known" funding level.
- If the Governor's Budget is released and includes any restoration of the GEA (in part or in whole) or any increase in Foundation Aid a restoration proposals will be presented at the April 7, 2015 meeting.

Discussion

Mr. Sample questioned as to what the tax impact would be and asked if it could be available by the next budget workshop meeting.

The NYS Governor's Budget is due out 4/1/15. Our final budget meeting/budget adoption is 4/7/15.

Mr. Nedeau asked what is done with the monies that are saved from the decrease in payments to the Teacher Retirement System. He wondered why these types of monies couldn't be put in a savings account somewhere and used to try to maintain jobs within the district and not have to always cut jobs when times get tough.

Mr. Sample asked why the Governor is being so stringent with the rules for the teachers in NYS. Lisa Grenville explained that he is looking mostly at comparing our teachers with the teachers of other countries like China and not with teachers from other states within the United States.
